

CONSENT TO THE PROCESSING OF PERSONAL DATA

pursuant to Art. 6, par. 1(a) and Art. 7 of the Regulation of the European Parliament and of the Council of 2016/679 dated April 27 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation - GDPR)

- in a justified case, as the person concerned, I have the right to lodge a complaint with the supervisory authority, which is the Office for the Protection of Personal Data of the Slovak Republic.
- I acknowledge that no cross-border transfer of my personal data to a third country takes place.
- I acknowledge that automated decision-making, including profiling, does take place.

Pursuant to Section 14 par. 3 of Act no. 18/2018 Coll., the data subject has the right to withdraw their consent to the processing of personal data concerning them at any time in the following ways:

- c) by sending a written request to the address of the operator's registered office stating the text "GDPR - withdrawal of consent" on the envelope.

Withdrawal of consent does not affect the lawfulness of the processing of personal data based on consent present prior to its withdrawal; the data subject must be informed of the above before giving their consent. The data subject may withdraw the consent in the same way as the consent was given.
